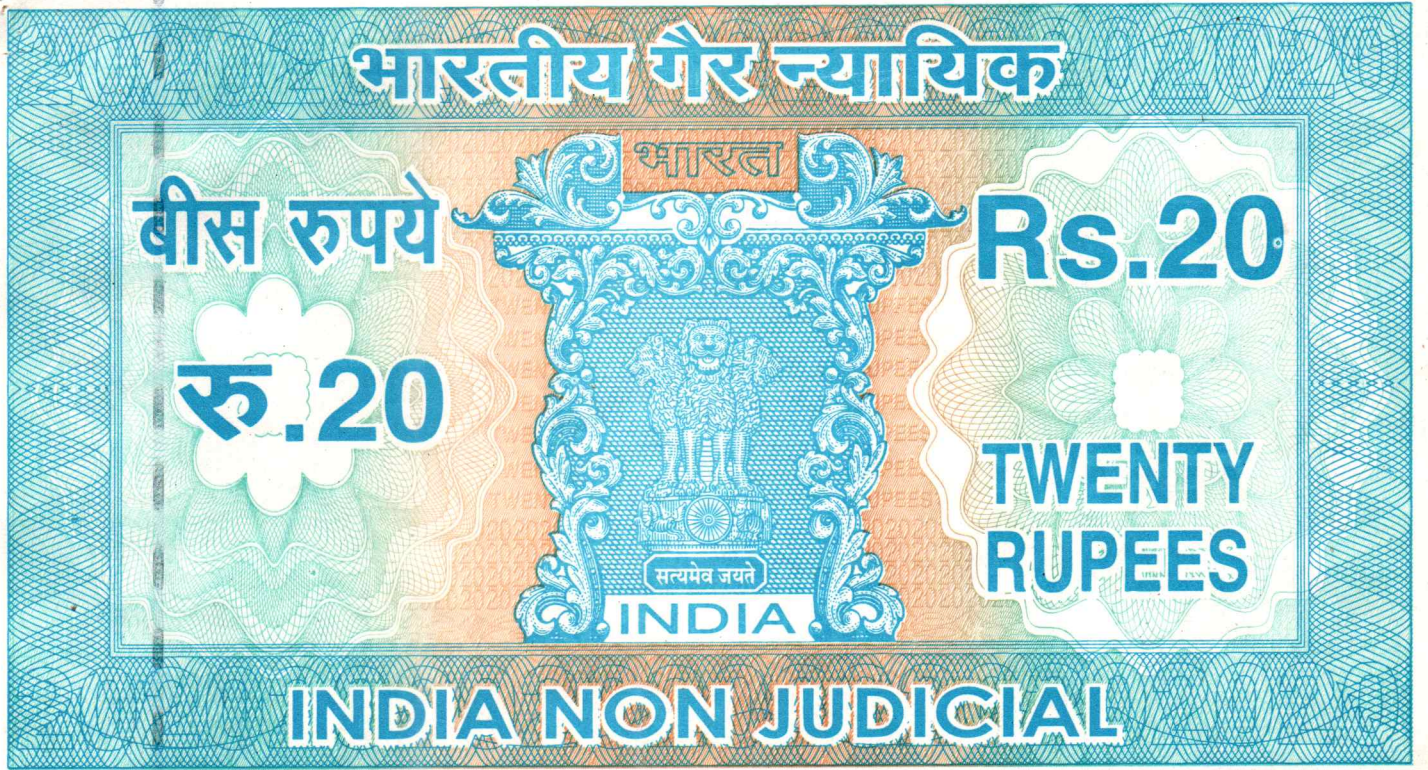
3. The Trust Deed shall be deemed to have come into force from the date of registration.

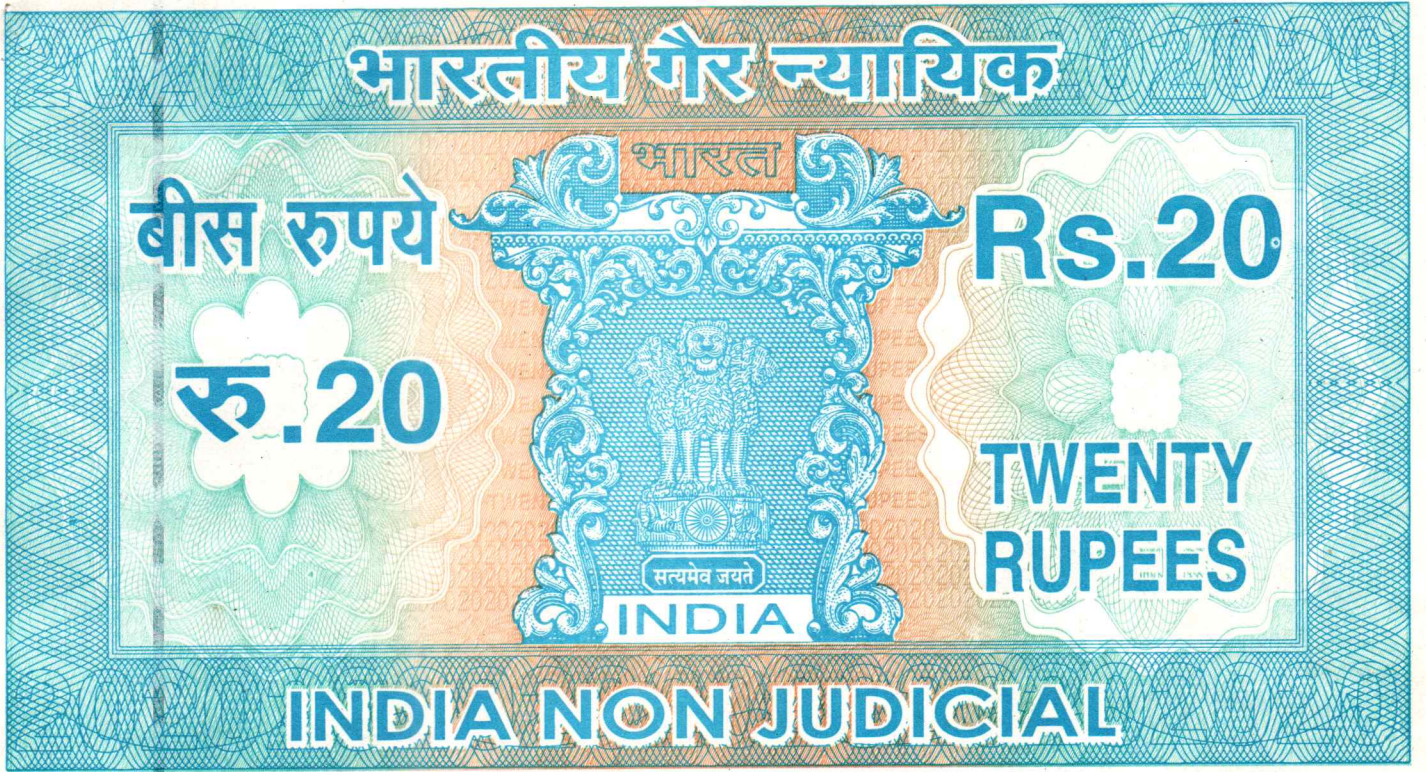

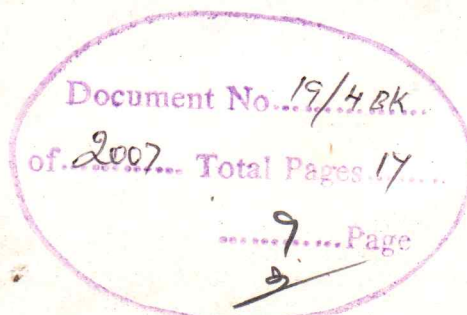

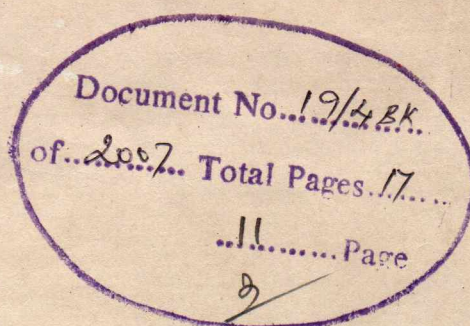

- 9) To start, maintain and assist any relief measures in those parts which are or become subjected to natural calamities such as flood, fire drought, famine, cyclone, earth - quake, epidemic, storm, accident, etc.

- 10) To publish and or publishing books, pamphlets, periodicals and newspapers in India for the spread and advancement of education and culture.
- 11) To join hands with social service organisations to eradicate deadly deceases and achieving family planning programme, polio, eradication etc, by co-operating with the state and central Government health care programmes at times of flood, natural calamities.
- 12) To abolish child labour and to propagate the evils of child labor.
- 13) To make awareness among the people about AIDS and to advise the people for maintaining character and discipline.

5. ADMINISTRATION

- i. There shall be an Executive Committee consisting of the Managing Trustee, Secretary and Treasurer. The founder R. STUART shall be the Managing Trustee of the Trust.
- ii. The Executive Committee shall be elected by the members of the trust.
- iii. The duration of the Executive Committee shall be permanent till the founder decided to change the executive committee of the Trust.
- iv. If any vacancy arises in the office of the Executive Committee, it shall be filled up by nomination of a new member from the Trustees by the founder.

6. DUTIES OF THE EXECUTIVE COMMITTEE

- i. The Managing Trustee shall preside over all the Committee meetings and any other meetings of the Trust.
- ii. In the absence of the Managing Trustee, the meeting shall be presided over by somebody among them elected or selected by the Trustees for conducting the meeting.
- iii. The Managing Trustee shall have executive and supervisory powers in respect of all matters relating to the trust.

12.

- iv. The Managing Trustee shall at his discretion carry out the decision taken by the Trustees.
- v. The Secretary shall assist the Managing Trustee in the matter of execution and supervision of all works of the trust.
- vi. The meetings of the Executive Committee shall be convened once in 3 months. In case of necessity, the meeting shall be convened at any time.
- vii. The Secretary shall convene the meeting of the Trust and the Executive Committee. The quorum for the Executive Committee is Two members. If there is no quorum in any meeting the same can be convened after one week. The resolution passed in such meeting shall be binding on all the members even if there is no quorum.
- viii. The Treasurer shall be the Custodian of all the records relating to the trust and the records shall be made available whenever required by any member. He will be in charge of accounts, and prepare annual statement of accounts for Audit by a Chartered Accountant.
- ix. All the Correspondence shall be carried on by the Secretary.
- x. The trust meeting shall be convened atleast once is Six months and the quorum of the meeting is 3 (three) members. If there is no quorum in any meeting the same can be convened after one week. The resolution passed in such meeting shall be binding on all the members, even if there is no quorum.
- xi. Every member of the Trust is obligated to attend all the meetings as far as possible.
- xii. Any Trustee can be removed by passing the resolution by the Trust.
- xiii. Any Trustee or the Executive member may resign from the trust by giving one month notice.

7. FUNDS OF THE TRUST

- i. The founder Trustee has set apart a sum of Rs. 1001/- (Rupees One thousand and One) only as a corpus fund of the Trust.
- ii. The funds of the Trust shall be contributions and donation made by Philanthropic institutions and individuals.
- iii. Aids and Grants and financial assistances received from Central Government, State Government and Local Bodies.
- iv. Sum or sums to be donated by way of testamentary dispossession in favour of the Trust by individuals.
- v. Income from the movable and immovable properties to be purchased in the name of the trust, in future.
- vi. Sums to be specially donated by the founder and others.
- vii. Funds to be raised by collection of subscriptions, donations, fees collections from students, miscellaneous receipts including Income from immovable properties and any other valid sources.

8. a. OPERATION OF FUNDS

- i. The Trust fund shall be invested in any of the nationalised Banks, Scheduled Banks or Co-Operative Banks as decided by the Board of Trustees or in the manner specified in section 11(5) of the Income Tax Act 1961.
- ii. The fund shall be operated by the Managing Trustee.
- iii. When a Trust member losses his/her membership he/she has no right to claim any amount from the trust.

b) ADMINISTRATION OF THE FUNDS

- i. To meet the day to day expenditure towards the maintenance of the Schools and other Educational Institutions.
- ii. To meet the expenditure towards the Institutions to be started.

- iii. To pay Salaries to the Staff employed in the Institution to be started.
- iv. To pay the sale consideration and to meet expenditure on account of acquiring movable or immovable properties for the trust in future.

c. AUDIT AND ACCOUNTS

- i. Proper accounts shall be maintained by the Treasurer with the approval of the Managing Trustee.
- ii. All the accounts shall be subjected to audit by a Chartered Accountant, appointed by the Executive Committee for this purpose.
- iii. Statement of accounts of every year shall be submitted before the Members of the trust meeting after having the same audited for approval.
- iv. The financial year of the Trust shall be from 1st April to 31st March of the next year.

d) APPOINTMENT OF STAFF

- i. All staff required for the functioning of the office of the Trust shall be appointed by the Executive Committee from time to time.
- ii. The appointment of the staff of all other Institutions belonging to the Trust shall be made by the Executive Committee with the prior approval of the Trustees.

9. GENERAL

- i. There shall be 5 members including the Founder and Managing Trustee.
- ii. It is hereby expressly declared that the Trust is absolute and irrevocable.
- iii. If any vacancy of membership in the trust arises due to the death or other reasons, it shall be filled up within one month by the Managing Trustee.

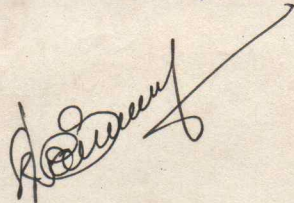
- iv. The documents relating to acquisition of immovable properties shall be executed in the name of the Managing trustee on behalf of the Trust. A Register showing the properties of the trust shall be maintained and constantly updated.
- v. The disposal of property of the Trust shall be decided by the Managing Trustee at the request of the members of the Trust.
- vi. The Founder – Managing Trustee shall be the permanent Managing Trustee of the Trust. If there is any problem, in taking decision in respect of any subject matter in the Executive, committee the Secretary and Treasurer shall have to act in consultation with the Managing Trustee in all matters.
- vii. The object of the Trust shall be carried out only in India.
- viii. In the case of dissolution or winding up of the trust in any manner, all the liabilities of the Trust should be paid off and the surplus funds and assets if any shall be transferred to any other organisation or Association or Trust having similar objects of this trust and which acts as per the conditions imposed and enjoys the concessions and recognized under Section 80(G) of the Income Tax Act 1961.
- ix. The members of the trust have power to amend the trust deed without altering the basic character and objects of the trust. But however no such amendments will be repugnant to the provisions of Sec.2(15), 11, 12 & 13 and 80 (G) of the Income Tax Act 1961 and these will be carried out only with the prior approval of Commissioner of Income Tax.
- x. It is open to the Managing Trustee to admit new more trustees. In any case the total trustees shall not exceed 10.
- xi. Men and women who attained 21 years of age and who are desirous of human welfare irrespective of caste, creed, sex, colour and religion is eligible for membership.

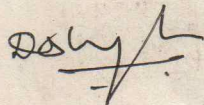
- xii. All funds of the trust and the income arising from investments of the trust funds shall be applied only for the purpose of the trust in such a manner as the members shall from time to time decide at the meeting in accordance with the objects of the Trust.
- xiii. No portion of the fund will be utilized for the payments to the trust members by way of profit, dividend or interest.
- xiv. Loans may be obtained by the trust from any Banks or Financial institutions to realise its objectives. Loans may be obtained by the trust from the members and others without interest.
- xv. The Trust members have no right in the trust properties on any account.
- xvi. The Trust shall not carry on any business for the purpose of profit.

(At present there is no movable or immovable properties except the cash of Rs. 1001/-) as mentioned in Para 8. The Trust building is rental.)

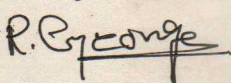
